NOMINATION DEADLINE SEPTEMBER 5TH 2008 (DATE OF POSTMARK)

Nominations per fax or e-mail are only accepted when the nomination fee is settled by a bank remittance or a voucher cheque within three days. The organizer reserves the right to not accept post-nominations – both generally or also for individual classes. The starting lists are closed at 7:00 p.m. on the evening of the day before the individual scheduled day. Possible post-nominations or changes of horses or exhibitors have to be reported to the show office until then. The starting lists for the following day are then drawn up and published.

When nominating a horse, please inform us if you wish to have straw or wood shavings for your horse or if you need a tack box. The organiser basically equips the stalls with straw. Wood shavings have to be bought locally. An additional fee of EUR 17 has to be paid for the disposal of wood shavings. If straw and wood shavings are mixed in a straw stall or if another litter is used (e.g. linen, chaff, etc.), a special disposal fee of EUR 50 has to be paid.

Nomination and stall reservations can only be approved if the nomination forms are filled out completely and arrive at the nomination office in time Starting fees and stall rents were fully paid.

USING THE MAIN ARENA

After the last class per day is over, the main arena is opened for training horses according to a fixed schedule.

DQHA FUTURITY/MATURITY

Only American Quarter Horses are admitted whose father was auctioned or bought at the Stallion Service Auction before the mother was covered. A foal born in 2008 can only be admitted when its father has been auctioned or bought at the SSA 2006.

The owner of the horse has to be a member of the DQHA according to the AQHA Registrations Certificate/Registration Application. To claim his breeding premium the breeder has to be a DQHA member in order . When the nomination is handed in, a copy of the registration certificate has to be enclosed.

When nominating horses by IMPRESSIVE in the Futurity/Maturity, the owner has to present a HYPP N/N pass approved by AQHA. This certificate has to be handed in by the owner, as otherwise no participation is possible.

For enrolling in the weanling classes, following information is crucial: when the foal is not yet registered with the AQHA when the nomination takes place, alternatively, a completely filled out registration application (copy) has to be presented with the copy of the certificate of registration of the father and the mother of the foal. The exact date of birth has to be entered.

When an owner has a Futurity/Maturity free start voucher, then an explicit indication for the nomination is necessary. Furthermore, the original voucher has to be attached.

Incomplete Futurity/Maturity nominations are sent back unprocessed.

The organizer reserves the right to carry out Futurity/Maturity-classes if necessary class in class with the corresponding AQ-HA discipline.

For the DQHA-Futurity/Maturity classes, the regulations of the DQHA set of rules 2008 as well as the amendments to the regulations stipulated at the previous annual meetings are applied. The regulations of the DQHA Futurity/Maturity normally do not allow any post-nominations!

The evaluation of the Futurity classes and the Champion of Champions are carried out according to the point system of the World Show. After the five judges make their assessment the highest and lowest rank drop out.

SHOW REGULATIONS:

In order to carry out the show, the regulations of the current AQHA / DQHA set of rules 2008 (including the amendment of the statutes passed in 2008) as well as the enclosed regulations:

- 1. Nominations can only be accepted if: The nomination forms are filled out completely and arrive (postmark) in time. Starting fees and other fees have to be fully settled and the nominator has to be a member. A copy of the 2008 AQ-HA membership card or Amateur, Youth or Novice card has to be enclosed. Memberships can also be concluded at the show office. A copy of the Certificate of Registration or the copy of the Registration Application for foals which are not yet registered and a copy of both the Certificate of Registration of the father and the mother of the foal have to be enclosed. The exact date of birth has to be filled in.
- 2. By submitting the nomination form, the participant / owner of the horse agrees to the announcement and to the applicable event regulations.
- 3. The organiser reserves the right to change the announcement and timetable until the nomination deadline, to postpone the event or to cancel the event and refund the nomination fee as far as special circumstances make this necessary.
- 4. There is no contractual relationship between the organizer on the one side, and the visitors, horse owners and participants on the other side. Moreover, any liability for theft, injuries of man and beast is excluded. Especially, participants are not assistants according to § 278 and § 831 German Civil Code. As soon as the nomination is handed in, each horse owner and participant and their escort and visitors agrees to follow the instructions of the organiser and the show management and adheres to the regulations stipulated by AQHA and DQHA.
- 5. The organiser is not liable for late or lost mail.
- 6. Each horse has to have a third party insurance. The horses have to be free of contagious diseases and have to come from stables which are free from infectious illnesses. Every horse participating in the show has to be vaccinated and therefore has to have a protection against influenza. Horse owners have to prove this vaccination by presenting a valid vaccination record on demand. The show management can refund half of the starting fee when a medical certificate is presented before the show starts. The cattle and office charge can not be refunded. Fees for the stall can only be refunded when it is possible to find a new lodger for the reserved stall.
- 7. Each participant receives a nomination confirmation with the current time-table before the event starts. It is the participant's own responsibility to arrive in time for his start. The organiser is entitled to prepone scheduled examinations by 30 minutes.
- 8. Dogs have to be kept at a leash on the entire show area. In case of disregard, the organiser reserves the right to expel the dog and his owner from the areal without prior notification.
- 9. Riding without a starting number or to lunge a horse. The entire area, especially the riding rings are checked for unsporting behaviour (also see set of rules §441,j).

10. The legal binding Announcement will be the German version "Ausschreibung Q8 Int. German Championships of American Quarter Horses" published in the Quarter Horse Journal and at the DQHA Website.

INTERNATIONAL GERMAN CHAMPIONSHIP FOR AMERICAN QUARTER HORSES

(The title refers to the horse)

For evaluating the international German Champion, the AQHA shows 1-4 are equally assessed. Thereby, the results are marked according to the point principle of the AQHA world show. If there is a tie, the individual tie-judge who has been drawn at the beginning of the show for the first time and who changes whenever he is needed.

All Q8 participants who fulfill the start preconditions for an AQHA show, are allowed to start.

If an applicant does not wish to participate at the German Championship for American Quarter Horses, he has to state that explicitly on his nomination/entry form.

Following doping regulations apply:

DOPING

By signing the nomination/entry form, each exhibitor or horse owner agrees to a doping test by urine or blood. All horses which participate in the Futurity/Maturity, the Int. German Championship for American Quarter Horses and the German Championship Reining, can be called to a doping test. The FN doping regulations according to § 441 AQHA set of rules 2008 apply. These do not allow any foreign substances. If a horse is tested positive, the exhibitor or owner has to cover the incurred expenses. The horse/exhibitor combination is then disqualified and has to return all moneys, prizes and his position. Moreover, the organiser reserves the right to take disciplinary action/ sanctions against the respective horse/exhibitor combination or the owner of the horse.

CLIPPING

As far as horse clipping is concerned, we would like to render following information: The official veterinarian in charge points out that any infringements of the current law leads to legal charges.

Here, the organiser does not take over any responsibility or liability.

NSBA FUTURITY

Western Pleasure and Hunter under Saddle Futurity: All three- to five-year old descendants stemming from recorded stallions (list published in the QHJ and at www.nsba-germany.de) are allowed to start.

Lunge Line Futurity: All one- and two-year old descendants stemming from recorded stallions are allowed to start.

Exhibitor and owner of the participating horses have to be members of NSBA of Germany.

The organiser and the responsible body for the regulations of theses classes is NSBA of Germany e.V.
